European Union countries use the European Union Council Framework Decision of 13 June 2002 on Joint Investigation Teams for setting up such teams.

In the case of money laundering, investigators begin by analyzing financial transactions in order to link them to corruption. Specific steps are likely to include the identification of persons, companies, and assets involved in the case and the connections between them, followed by an analysis of the assets and financial flows.

As many as 678 corruption cases were under investigation by the Central Bureau of Investigation (CBI), 25 of them for more than five years, as on December 31, 2019, the latest report by the Central Vigilance Commission has said. The CBI is normally required to complete investigation of a registered case within one year.
